From the Rector's Desk 🖺

Let's talk about sex this month. ('Bet that got your attention, didn't it?) Anyone who reads the news or watches television has, no doubt, heard of the crisis affecting the Roman Catholic Church. Each day, it seems, more and more cases of child sexual abuse come to light in the United States, Ireland, Germany, and elsewhere. Some bishops seem to have been apathetic and indifferent to the conduct of priests under their charge. When abuse was alleged, rather than taking what most would consider appropriate action, the priest in many cases was simply reassigned, and the parish to which he was reassigned was not even warned of the priest's conduct in his previous parish. Requests by bishops to depose ("return to the lay state") were met by years of silence, delay, stonewalling, and pleas to "Consider the good of the wider Church."

But this is not a column about the misdeeds of others. For one thing, I am no expert on Roman Catholic polity. For another, I know that the vast majority of Roman Catholic clergy (and laity, for that matter) are good and faithful people trying their best in difficult circumstances. Loss of membership, shrinking budgets, and fewer people seeking religious vocations are problems affecting many churches, including both the Roman Catholic church and our own.

No, what I wanted to talk about this month is sex in the Episcopal Church. More specifically, I want to introduce you to the policy of the Diocese of Virginia regarding sexual abuse and misconduct, both the prevention thereof and the response to it, should it occur.

The basic policy is about a dozen pages long. But there are also eighteen tabs, some of which are divided into sub-tabs. Just about anyone who does anything in the Episcopal Church – more specifically, in St. Peter's Parish Church – is required to read the basic manual. But the basic manual also defines which tabs or sub-tabs must be read, depending on one's position within St. Peter's.

Before this gets too complicated and I go too far afield, let me illustrate. An organist, choir director, or music director is required to read the manual plus Tab B (Screening, Recruiting/Hiring, and Training), Tab F (Organists, Choir Directors, and Music Directors), Tab S (How and Where to Report Suspected Child Sexual Abuse and Adult Sexual Misconduct), and Tab T (Response to Reports of Child Sexual Abuse and Adult Sexual Misconduct). In addition, the full Child Sexual Abuse Prevention Workshop is required, as is the Adult Sexual Misconduct Workshop. A criminal background check, job application, reference check, and background check are also required. Finally, there must be no child abuse conviction on his record. The tab specific to Sam's position is Tab F (see above). The list of positions is long and comprehensive, covering everyone from clergy to secretaries, parish administrators to nursery and child care workers, vestry and wardens, youth workers and sextons. Everyone reads the manual and some specific tabs.

Let me close with some quotes. Tab S-1 is "How and Where to Report Suspected Child Sexual Abuse." First heading: All Allegations Should Be Reported to Child Protective Services. Under that we read "The initial report for all suspected child sexual abuse should be made to Child Protective Services via a statewide toll-free hotline at 1-800-552-7096." When to report to the church? If the abuse occurred on church property or during a church event; if the suspected abuser is a member of the clergy; or if the suspected abuser gained access to the child through relationships at the church. No allegations or complaints should be ignored. If the suspected abuser is a member of the clergy, call the Bishop at the Diocesan office (1-800-DIOCESE), ask to speak to the Bishop, and say that it is both urgent and confidential. If the suspected abuser is other than a member of the clergy, report it directly to the Rector or other appropriate member of the clergy.

My view of our Vestry Retreat is anything but that. Our agenda contains an evaluation of what we have done well to discussing items of concern. We plan to set goals for our service to St. Peter's and to identify every opportunity to maintain and increase the involvement of our church family with various programs and activities. It's a tall order, but one that has proven to be a blessing to our personal and leadership oversight.

Unquestionably, we will return from our Vestry Retreat with a revised spirit *To Love and Serve the*

Pastoral Care

Prayer, care, and concern for our fellow parishioners and their families and friends are a vital ministry at St. Peter's. There are several ways to make any pastoral care needs known: 1) you can call the Church Office, 2) contact Jean Mansfield, or 3) contact Nancy Goodman. Jean is the chairperson for the Pastoral Care Commission and Nancy is the Vestry Liaison.

In an effort to improve our prayer list for illness, we have divided the names to make two lists, one for short term needs and the other for long term care. Both of these lists are kept in the notebook on the podium in the Parish House foyer and are updated often. Many of you are already familiar with making additions to or deletions from the lists in this notebook. If you choose to do so, please make the change to either the short term or long term list and note your relationship to the person named.

The short term list will be used for parishioners, their families, and friends having an illness that is not expected to last long. Their names will be kept on the list for 30 days unless we are advised to keep them on longer.

The long term care list will include names of home bound, serious conditions, etc. Names will be kept on this list until we are notified to take them off. If you have a long term situation and would like to share it with us, we have a confidential list letting us know about the situation and how best to contact these individuals with cards, visits, phone calls, etc. We will not post or provide information to anyone to protect the privacy of individuals on the confidential list.

It is very important to keep us informed about names on both lists so we know how to best provide pastoral care. It also helps us keep accurate records for the reading of the prayers on Sunday mornings.

In addition to pastoral care for the ill, the commission keeps a prayer list of individuals serving in the military. Please let us know when to add or delete someone from the military list.

Martha's Gift Shoppe Update

It occurred to me during the congregational Annual Meeting that I need to be giving regular updates on what Resource and Development does as a commission of the church. We have been in existence since 1992 and started as a commission of St. Peter's to raise money for the church for those things not covered by the budget. We started out researching and developing items (hence "R & D Committee") and projects connected to our church by design or historical significance. Our first project was a t-shirt/sweatshirt design, funded by two of our members, since we had no start-up money. We doubled our money on that project and used that income to fund the next project. Over the years, we have developed items for sale from ornaments, door stoppers, books, jewelry, bookmarks, and cookbooks. We have held several fund raisers such as the *Trash or Treasure Sale* at the county fair. A Vestry member asked me if we really make any money. We now have around \$40,000.00 worth of merchandise to sell and have approximately \$10,000.00 in our bank account, with no debt.

Our beloved Anna Davis retired as one of our Co-Chairs January 2009. She is still a part of our committee and Peg Noctor, thankfully, took her place. There are twelve of us. We would love to have more members and more marketing ideas. If any one of you has an idea, we would love to hear it.

So, where has the money gone? We have provided the funds for items including a piano, our new fire cressets, a dishwasher, two ovens, a highchair, blinds, vacuum cleaners, Sunday School supplies, and many other needs over the years. If you have a need, send us a written request before you purchase, please. If it is something to add to the buildings or grounds, you will need Vestry approval first. We are a Historic Landmark and there are rules regarding what can be added to the building. Our committee is also required to have the Vestry's approval if the item costs more than \$1,000.00.

We have appreciated all of your support over the years. We hope to continue to be successful in our service at St. Peter's.

When it comes to adult sexual misconduct (Tab S-3), "Anyone who learns of sexual misconduct by a colleague is obligated to report that misconduct to appropriate church officials in the event the victim or offender refuses to do so." It should be reported to a member of the clergy from the affected parish, but if a priest is involved, another member of the clergy from the parish should be notified. If the priest involved is the only clergy for the parish, the parish warden should be notified. Then "the clergy member or warden receiving the report of suspected misconduct should promptly notify the Bishop's office."

From my experience on April 15 involving my being a witness to the deposing of another priest, I can tell you that Bishop Shannon takes both child sexual abuse and adult sexual misconduct quite seriously. I share his concern, and I promise you that I will work towards making sure that St. Peter's is in compliance with both the letter and the spirit of the Diocesan policy.


